## **BLOCK SEAT AGREEMENTS**

A block seat deal is a **signed agreement** between a Tour Operator and Wizz Air. Block seat means that in exchange for a **flat fare** on a specific route throughout a season, the Tour Operator **commits** to purchase (and prepay for) a fixed amount of seats (minimum 20 seats/departure) on the same day of every week, for a flight period spanning **at least 11 consecutive weeks**.

- **Fixed, flat price** for the whole season
- **One checked bag/pax** is included in the price
- **Airport check-in** fee is included in the price
- **Open name booking** up to 72 hours prior to departure
- **Special payment conditions:** (10%-20%-30%-40% payments)

Please note that block seat agreements are **not cancellable**.

## **GROUP BOOKINGS**

If you want to make a reservation for a group between 11 and 50 passengers and **at least 15 days prior to departure** you can search for flights and book online via wizzair.com. You need to (register and) login to **book groups**.

1. Once you have logged in please select the route and scroll down for the number of passengers you would like to add.

(A) If your group has up to 50 passengers you will get the price quote immediately online and can book your flights straight away.

(B) If your group has more than 50 passengers, send your request to the call center by clicking the "send request" button. You will receive an offer via email within 2 working days.
